No destructive, invasive testing, special testing or calculations are included in this proposal. A measured survey is also not part of this examination and if drawings are available these will be reviewed on a cursory basis only to determine the overall layout of each building. No detached structures, or other ancillary areas outside of the main building are part of this inspection. Specialists testing or examinations; such as those required for fire sprinkler protection equipment, kitchen equipment, hazardous materials, electrical load testing, elevator inspections etc. are not part of this inspection. This should also not be a construction or a structural engineer evaluation. We have attached our building inspection agreement for your signature upon acceptance of this proposal.
